### **CPCA SECURITY**

CPCA and our neighbors live in a community with a low crime rate.

The CPCA have initiated several safety initiatives to help keep our community safe and maintain a low crime rate.

First, we encourage all neighbors to report any suspicious activity to the Police by calling 911.

If it seems suspicious or concerns you, please call 911 to notify the Police to let them do the investigating. 911 is the best and quickest way to notify the Police of this type activity

Second, we have for over 20 years hired 5 off duty Cobb Police Officers to patrol, in marked and unmarked cars, the 35 plus miles of roads in our neighborhood to help combat crime and make our neighborhood safer.

Third, we and our neighbors have also (in cooperation with the Cobb County Police) placed 7 security License plate reader (LPR) cameras on our roads and property. (LPRs) are known locally by the popular brand name

"Flock" cameras. Police departments have been using them for several years. LPRs are amazing crime fighting tools and they are most effective in the hands of communities that collaborate with Law Enforcement to prevent and solve crimes Only the Police have access to the data bases "hits" that these LPRs check to identify suspicious vehicle traffic going in and out of our neighborhood. The databases rapidly scanned by the LPRs include BOLO (be on the lookout) files from multiple police agencies, stolen-vehicle files, the state sex offender registry, and lists of missing persons, as well as terrorist watch lists and other criminal justice databases. When there is a match between the tag of any passing vehicle and any of the databases, the system immediately transmits the information to the local 911 dispatch center and all patrol cars in the vicinity so they can narrow their searches. This happens in seconds

LPR camera technology is amazing, but cameras alone cannot apprehend dangerous suspects. Boots-on-the-ground Police officers, guided by sound Police policies, are necessary parts of the overall strategy to track and apprehend suspect(s). The officers must follow careful *felony stop* procedures to stop the vehicles identified by the LPRs and get the occupants safely under control.

Once the occupants of a suspect vehicle have been secured, the officers meticulously verify the LPR messages for accuracy to be sure they have the correct vehicle and suspect(s). They must also follow legal procedures to compile probable cause to take any further actions such as conducting searches, seizing weapons or contraband or arresting suspects. Technology never supplants an officer's responsibilities or anyone's constitutional rights.

One final benefit of LPRs is that they are not limited to use by the police. Private organizations and businesses that have venues with vehicular traffic, like subdivision homeowners' associations, often elect to pay for and install their own LPR cameras. There is, however, one caveat; they must coordinate with their local police. Only the police have online access to most databases LPRs use and therefore only the police can receive and respond to hit information. Nonetheless, the Police are happy to oblige since it helps accomplish their mission of serving and protecting as well.

Remember if you see any suspicious activity CALL 911.Please report it to the Police.

#### Some points to remember:

Never let anyone in your home who is trying selling door to door. Speak through the door but do not let them in.

As the old but true saying goes, "If it is a deal sounds too good to be true, it is probably is." It will most likely cause you to spend money uselessly and might expose you to a dangerous situation.

Lock your car doors, home doors and set your alarm when you leave even if it is only for a short time. Several of the burglaries in our neighborhoods were at homes with alarms that the owner did not set because they were only going to be gone for a little while.

#### A PERSONAL MAIL THEFT STORY

I have lived in the Atlanta Country Club community for 30 years. I also have a business located at Paper Mill Village Office Park which is behind the Starbucks at Johnson Ferry and Paper Mill Road. Recently, and after the daily box pickup time, my bookkeeper placed a check in the blue United States Postal Service box located within Paper Mill Village. That check was intercepted, "washed" and two checks were presented to my bank (Truist) made out to a name different than the one originally placed on the check. Truist honored both checks. Fortunately, the day after they were honored, my bookkeeper saw them coming through my account online and notified me. We caught it fast enough that Truist was able to reverse the money out of the criminal's account and put it back into mine.

Here is what the criminals did. One of the checks was "washed" and only the payee's name was changed." The other check that was presented to Truist was completely modified. They changed the check number (moving it forward about 200 numbers), and the payee was changed while leaving my account number, my business name, and my signature. The second check appears to have been counterfeited using my original check as a "template". Ostensibly, there is computer software capable of duplicating an entire check (including my signature) and allowing the criminals to change select information (payee, check number, memo line, etc.).

I've always (naively) thought that the blue USPS service boxes were safe for mail deposits. Apparently, they are not. Apparently, there are ways to get mail out of the USPS boxes. I've read that some of the master keys have been stolen from the Postal Service and are now available for criminals to gain easy access to these boxes. After the event happened, I was warning my business neighbors in Paper Mill Village and was informed that, on the same day, it happened to them as well.

Now that this has happened, I've done a bit of research and discovered there are indeed various ways to remove checks from these blue Postal Service boxes. I won't bore you with the details because you can look it up online. Suffice it to say, I will not deposit checks into a USPS box in the future. The new instructions for my staff are to write as many checks online as possible and when we absolutely have to write a hard check to only hand those

envelopes to a postal worker or deposit them inside an actual Post Office building and then only into one of the wall receptacles. It's a bit more trouble but dealing with

closing and re-opening a new bank account is trouble too.

Because the account was compromised, Truist required that I close my business account and open a new one. That means that all the auto-pays and auto-deposits have to be reconfigured and new checks have to be purchased. There is also an investigation that required me to spend nearly an hour on the phone with their fraud investigation department.

On the upside, I recently read that several criminals have been apprehended locally for this type of behavior. Though, I imagine, there are yet other criminals out there willing and capable of doing the same thing.

Please learn from my misfortune and be extremely careful with your checks. If you can't pay your bill online and must write a real check, I suggest you carefully consider where you choose to deposit that mail.

### **BOUNDARIES OF CPCA**

This area has approximately 1200 households comprised of 14 smaller neighborhoods, along Columns, Johnson Ferry, Powers, Paper Mill, Woodlawn, and Atlanta Country Club. When the CPCA addresses issues like zoning variances or concerns about roads to county or state officials, we get their attention because of our numbers. Your CPCA has maintained the use of off-duty Cobb Police to patrol our community randomly to show police presence and to help deter crime and address public safety issues. CPCA is a conduit for important notifications of criminal activity in our neighborhoods through our email and calling post contacts. Your dues pay for 60 hours monthly of police patrol in our neighborhoods. *If you have paid your dues for 2023, thank you.* 

#### **TREASURER'S REPORT**

- **December 31** (New Year's Eve) Fireworks may be discharged until 1 a.m.
- **January 1** (New Year's Day) Fireworks may be discharged until midnight.
- On the last Saturday and Sunday in May -Fireworks may be discharged until midnight.
- **July 3** Fireworks may be discharged until midnight.
- July 4 Fireworks may be discharged until midnight.
- **On the first Monday in September** Fireworks may be discharged until midnight.

## **CPCA AT WORK IN DEVELOPMENT**

Several years ago, the Chattahoochee Plantation **Community Association Board Members met** with Columns Gate Association representatives, members of the Cobb County Planning Commission, Bob Ott, Attorney Garvis Sams, and various homeowners that live in the Columns Gate subdivision regarding the development of 4650 Paper Mill Road. This parcel of land is over 3 acres. The original variance from 2018 requested 7 homes to be built and a retention pond to be constructed that was practically sitting on top of the residents of Columns Gate. With a lot of homework, both representatives of both Associations initiated emails to the Cobb County Commissioners, initiated diligent perseverance, appeared at the Board of Commissioners Meetings, reported on impervious surface calculations, and reviewed set back requirements. The owner of the land decided to sell the land as six lots instead of seven. Similarly, the CPCA variance and zoning committees have worked with other neighborhoods and officials to affect the rezoning and rebuilding plans of Starbuck's at Paper Mill Village. This is one of the many important functions of your CPCA - working with other associations and neighbors who live in the CPCA area helping in preserving our beautiful community and doing our best to ensure it remains that WAY.

### MAINTENANCE AND BEAUTIFICATION

The maintenance and beautification of the 13 islands and entrances is maintained by the CPCA. This includes seasonal plantings, pine straw refresh, irrigation, lighting, and normal weekly maintenance.

The CPCA also provides Holiday wreaths at our entrances and flags for our national holidays. Your support to the CPCA will enable us to maintain and manage the appearance of our community. Many thanks to Steve Edison for ensuring that our holiday wreaths are placed on the entryway walls each December and storing them the rest of the year. Another reminder: U.S. Postal authorities recommend your placement of your outgoing mail in the slots inside the post offices. Thieves are accessing the outside mail receptacles and at shopping centers also.

ENTRANCE ENHANCEMENTS

With the help and encouragement of several of our neighbors and other CPCA board members, we are working to define a design plan to complete the landscaping at both Paper Mill ACC entrances. There are a couple of reasons for the timing of this effort:

Recent fall and spring annuals have failed to flourish. At the Thunderbird entrance, the annuals died completely. We are working to discover the root cause and remedy the issue before making any additional investments

There are large areas for annuals at the entrances which require a large number of annuals for a plentiful and colorful display. Given less than half of our ACC neighbors contribute to the CPCA, there is not currently the interest and support for such a large bi-yearly investment.

When the entrance walls were built, more extensive perennial plantings were envisioned to complete the area. Although a design and installation will assuredly cost more than annual flowers, the investment will provide threeseason interest, the impact will be lasting and the designed plan will greatly decrease the need for yearly annual flower expenditures.

Neighbor Steve Edison was kind enough to uncover a plan from when the walls were constructed. Neighbor Mitch Rhoden and his design team at High Ground Landscapes are involved and we've contacted two other area firms with landscape architects. Our hope is to finalize a plan by early September in time for a fall installation. The CPCA has set aside a portion of funds to help with the project but we will need additional neighbor support to complete the vision. Additionally, after installation, these areas will need tender care during the first year or two of maintenance in order to become strong and established enough for a typical maintenance routine.

### **Other Maintenance and Updates**

There were efforts in the spring to add pine straw to the islands and entrances. Crepe myrtles in the islands on Columns were downed. Unpruned crepe myrtles were blocking delivery trucks at one of the islands. Weekly maintenance landscaping costs use most of the funds gathered. Pat laffaldano and I recently joined the CPCA board in this beautification role. We are working to identify how best to prioritize the donations available and we genuinely

welcome and appreciate neighbors helping with island needs brought to their notice.

#### **MCFARLANE PARK**

McFarlane Nature Park has been serving the community for 30 years, and in this anniversary year McFarlane is pursuing

new ways to make the Park relevant to our neighbors and friends.

During the spring months, special events have included a Plein Air Painting Day attended by over 20 artists; a visit from Cobb County Bluebird Expert Jim Bearden attended by 17 hardy visitors in 29 degree weather; Cobb County Arborist Dave Griffin provided a Walk N Talk featuring the native tree collection; and most recently Becky Griffin, the UGA Pollinator Specialist visited the Park to talk about the ways we can enhance our environment for the pollinators that we depend on.

Most recently Eagle Scout Lucas Elmiger completed a walking trail that features 18 stations throughout the Park. The goal is to take visitors to parts of the Park they may not normally visit and enhance their experience while they get their steps. Jayden Wen, another Eagle, geolocated much of the Park's tree collection in preparation for pursuing arboretum status.

Perhaps most importantly, the board voted to pursue an endowment fund to ensure the future of the Park. McFarlane Forward Fund has an initial goal of \$100,000 before any funds are allocated to the operating budget. Beyond that initial goal, the principle will remain intact with only the increase being drawn on for operating expenses. Donations have already taken the endowment to 30% of that initial goal. Donors of \$1,000 or above will be recognized as founding contributors to the endowment.

Because the Park receives no government funds and has always operated on donations, the purpose of the endowment fund is to make the Park more self-sufficient. Donations can be made to The Cobb Land Trust Inc., PO Box 672652, Marietta 30006.
